# A LETTER FROM THE MOST REVEREND PAUL S. LOVERDE BISHOP OF THE DIOCESE OF ARLINGTON

# A LETTER FROM TIMOTHY R. COTNOIR, CPA DIOCESAN FINANCIAL OFFICER



Dear Fellow Members of our Diocesan Church,

In Matthew's Gospel there is an account of an incident in which the Pharisees attempted to entrap Jesus by asking if it was lawful to pay a census tax to Caesar (Mt 22:15-22). While holding a coin, Jesus asked them whose image was presented. When they replied "Caesar's," our Savior gave the oft-quoted directive to "repay to Caesar what belongs to Caesar and to God what belongs to God." I have always been struck by the idea that we are to "repay" the person whose image we encounter. Jesus Christ invites us to look to where God has imprinted His image in our lives, namely in the innumerable blessings we have received, and repay Him in just proportion.

With this in mind, I present this Annual Report—on behalf of Bishop Paul S. Loverde and the Diocesan Finance Council—to you, the faithful of the Catholic Diocese of Arlington: first, as an accounting of the assets you have entrusted to the diocese, and second, as a reflection of the impact the ministries and offices in the Church have in meeting the needs of our brothers and sisters. Financial matters are presented in this report with respect to the parishes and schools of the diocese, as well as the Central Administrative Offices. Additionally, this year we have focused on the significant effects the many programs, ministries, and offices have had on all of the people who reside in the 21 counties and seven cities of our diocese.

During the fiscal year ended June 30, 2014, the diocese was blessed with the continued generosity of the faithful in order to fund the programs and offices managed at the diocesan level. Of particular note, extraordinary gifts

were received with respect to Bishop Loverde's Partners United in the Heart of Christ - Leadership Initiative 2015 program. These donations are restricted in their use, and are part of a strategic effort that is further explained in this report on page 9. Also, due to much improved market conditions, a second year of positive investment returns has been realized, and serves to support reserves for possible future market uncertainty. Bishop Loverde and I remain committed to providing transparent accountability along with infusing the highest standards in stewarding the gifts graciously given to, and received by, the Church. Please feel free to contact my office with any questions, suggestions, or concerns regarding these reports.

# STATEMENT OF ACTIVITIES HIGHLIGHTS

Operating income for Fiscal Year 2014 demonstrates the continued generosity of the faithful within the Diocese of Arlington. Individuals responded to the call to increase their Bishop's Lenten Appeal (BLA) donations, which provided more than \$16 million to support the pastoral, vocational, educational, and social services ministries of the diocese. The growth of the BLA, together with restricted contributions and endowment income, provided funds for increased expenses in the area of evangelization, seminarian education, and charitable assistance. Parish assessments, investment income, and direct program revenue all served to fund diocesan offices in accordance with the approved budget.

In fiscal year 2013, Bishop Loverde launched the *Partners United in the Heart of Christ ~ Leadership Initiative 2015*, a targeted major gift program to meet the most critical funding needs of the diocese in the areas of Catholic education, new evangelization efforts, support for our retired priests, Catholic Charities programs, and various capital improvements. Pledges in excess of \$35 million have been raised, allowing for initial funding of the critical mission priorities identified, including grants to diocesan high schools in support of capital needs and contributions to Catholic Charities for its St. Lucy food distribution hubs and transitional housing programs. These contributions also provided funds to grow the Tuition Assistance Endowment and help meet the future pension obligation for our diocesan priests.

This year's positive investment performance is reflective of the increase that has occurred in the overall financial market. Spending policies remained consistent to provide a predictable stream of funding to programs, at a level supported by interest, dividends and realized gains, and providing for real growth in the investment corpus. Although the market trend may be volatile

in the future, we remain confident in the long term view of the market as it pertains to our investment horizon for those assets invested, as well as the prudent investment policies and oversight exercised by the various diocesan financial advisory committees. Insurance programs (health and risk management), although met with increased costs in fiscal year 2014, netted positive results, increasing reserves to cover future claims and market increases. The negative change in the priests' pension and postretirement health obligation was primarily the result of actuarial adjustments due to a decrease in discount rates used in determining benefit obligations.

In October 2013, the Chancery completed the defeasance of the 2003 bonds payable, placing the Chancery in position to realize savings as result of the favorable terms of the refinanced bonds. The Chancery has advanced funds to Saint John Paul the Great High School to supplement tuition in covering operating costs, including rent. Conservatively, a reserve was established for the advances. This reserve is expected to decrease as school enrollment continues to increase.

Overall, the Chancery ended the year with a significant increase in net assets. Results from operations reflected a surplus of revenue over expenses amounting to \$9.3 million, due to a fruitful start to the Leadership Initiative 2015. These positive operational results, coupled with extraordinary investment returns from improved market conditions, have contributed a \$20 million increase in net assets for the year ended June 30, 2014. Although in fiscal year 2014 the diocese experienced exceptional growth, fiscal year 2015 program budgets will remain focused on critical missions based on measured growth, and strategic long-term needs supported by donor contributions identified for these purposes.



# OPERATING INCOME

**Bishop's Lenten Appeal (BLA)** accounted for more than \$16 million in income in 2014 to support ministries and programs throughout the diocese. BLA contributions fund pastoral programs, religious personnel development, education, and social services, as well as contribute to the administrative support of ministries and offices at the diocesan level. The continuing generosity of the faithful of the diocese is clearly demonstrated by the 6% increase over the prior year.

**Parish Assessment** accounted for over \$7 million in operating income in 2014. This income is calculated and paid by parishes as a function of the regular parish offertory. Eight percent of the parish offertory (as of June 30th) is computed and paid monthly in the subsequent year. Total assessment funds increased 4% over the prior year, with most parishes reporting an increase in offertory, a few reporting a decrease. This income supports offices that serve parish, school, and diocesan administration (e.g. Office of the Bishop).

**Investment Income for Programs** totaling more than \$1 million reflects the budgetary amount anticipated from the investment returns of diocesan reserves. Actual investment returns may or may not be indicative of that which is budgeted and utilized for operational need.

**Program Revenue** includes registration and professional development fees for a variety of initiatives, including Youth Ministry's WorkCamp, World Youth Day, Conferences for the Engaged, and Catechetical Certification. Amounts contributed to and received by the Tribunal are also included in program revenue.

**Donations, Bequests, and Misc. Contributions** totaled over \$20 million. Current year donations and collection of prior year pledges continue to be a source of funds for both donor-supported programs and long-term strategic funding needs securing the future growth and well-being of our diocesan church. Because the Leadership Initiative 2015 campaign is aimed at specific, long-term needs of the diocese its results are shown seperately from "operating" income (page 4) and reported on page 9.

# **OPERATING EXPENSES**

**Pastoral** offices include those involved with evangelization, Youth and Campus Ministry, the Office for Family Life, the Respect Life Office, the Spanish Apostolate, the Office of Multicultural Ministries, the Permanent Diaconate, Tribunal and Parish Subsidies, the Virginia Catholic Conference, the diocese's support of two missions in the Dominican Republic, St. Rose of Lima Priests' Retirement Villa, and the San Damiano Spiritual Life Center.

**Religious Personnel Development** includes the Office of Vocations (seminarian education) and other religious personnel development programs.

**Education and Faith Formation** includes the Office of Catholic Schools, the Office of Catechetics, and the Tuition Assistance Program.

**Social Services** include the diocesan subsidy of Catholic Charities, the Office of Child Protection and Safety, and other charitable causes.

**CURRENT OPERATIONS** 



The diocese maintains assets for current operations to support ongoing programs, ministries, and future capital needs. Pledges and accounts receivable include major gifts and Bishop Lenten Appeal pledges that will be used to fund programs into the next fiscal year. Investments have increased with the contributions received from Leadership Initiative 2015 contributions and positive investment returns. Investments also include longer-term funds of DIAL Corp held in the investment pool.

# PROPERTY AND EQUIPMENT

The diocese is required to report the real property, land, and equipment that it holds for diocesan uses. This includes the land and the original buildings and grounds of the diocesan high schools and other affiliated organizations under the office of the diocesan bishop. The \$11 million in land for future parish and diocesan needs is demonstrative of the continual emphasis on growth and development, and the diocesan commitment toward that growth. As a result of the utilization of bond proceeds for the Pope John Paul the Great High School construction, the associated bond debt is included as an offset to the asset. In December 2012, the Chancery entered into a new financing arrangement obtaining \$21 million in bank qualified tax-exempt financing for the purpose of defeasing the 2003 tax exempt bonds. The loan proceeds were placed in escrow to be used to pay the scheduled debt through October 1, 2013, at which time the 2003 bonds payable were redeemed. The refinance provides more favorable terms, and together with the interest rate swap agreement entered into in May 2013, effectively fixed the interest rate at 2.482% over a 15-year term. Also reflected in assets is the estimated unrealized gain on the swap agreement, based on a fair value calculation which anticipates an increase in interest rates in excess of the fixed rate established by the swap agreement. This value will change as estimated forward rates change. The savings result of the refinance is in excess of \$10 million over the next 15 years.

# PERMANENT ENDOWMENTS, ADEF, AND FUNCTIONING AS ENDOWMENT

An endowment is a specific fund that generates investment returns to help an organization or specific program, while preserving the principal funds initially invested. Redemptions from Rooted in Faith~Forward in Hope capital campaign pledges have provided endowment funding in excess of the \$20 million goal established for tuition assistance, school faculty development, and catechetical programs, youth ministry, and Catholic Charities operations. Although the RIF-FIH capital campaign has ended, it is anticipated that these endowments will continue to grow with the continued support of contributors to these programs. In 2013, with the start of the Leadership Initiative 2015, the tuition assistance and Catholic Charities endowments have been added to, and all endowments have experienced growth with the exceptional investment market returns. These endowments, overseen by the investment committee of the Diocesan Finance Council, provide annual income for these program initiatives. The Arlington Diocese Education Foundation (ADEF) serves as a means for parochial and regional schools, as well as the diocese, to provide additional annual funds for educational purposes. The original patrimony of the Diocese of Arlington, contributed at inception, has been preserved and invested to function as an endowment for operations. Collectively, all of these funds are managed as restricted investments with a predictable amount budgeted to be utilized annually to support the intended programs or ministries.



# **EVANGELIZATION AND OUTREACH**

Throughout the past year, Bishop Loverde has continued to invite Catholics to a life more rooted in Christ and His Church. The theme of "hearts on fire" and our need to "go forth" and share the Good News—the topic of his letter, *Go Forth with Hearts on Fire*—has been the focus of numerous ministries, events, and small groups. Author Matthew Kelly wrote of the letter, "It is profound and practical. I hope the whole diocese gathers around Bishop Loverde to bring this bold vision to life." A significant effort during the past fiscal year was focused on planning the first-ever evangelization conference, dedicated to personal spiritual renewal and developing Christian community. Risk Jesus, which took place on September 27 and attracted more than **1,300 attendees**.

## PARISH-BASED EVANGELIZATION EFFORTS

Go Forth with Hearts on Fire, and its complementary study guide, served as the focus of the annual diocesan men's and women's conferences, the Youth Ministry "Go Forth and Make Disciples" theme, a new diocesan online speakers' bureau, and a variety of diocesan and parish-based workshops and discussion groups. # GO FORTH WITH HEARTS ON FIRE

On Christ the King Sunday on November 24, 2013, Bishop Loverde released his pastoral letter on the New Evangelization, *Go Forth with Hearts on Fire.* Since that date, nearly **200,000 of the English** edition and **30,000 of the Spanish edition** have been sold or distributed, and the letter is available online for Kindle at Amazon.com. "My hope is that reading the letter, praying over it and discussing it," Bishop Loverde said recently, "will first of all set people on fire in a way that they will be moved to invite others to come to the Lord."

# YOUR ARLINGTON CATHOLIC HERALD: SUPPORTING THE CHURCH'S MISSION TO EVANGELIZE

The Arlington Catholic Herald received over **15** national awards from the Catholic Press Association and hit a new high of **70,000** subscriptions. In an effort to strengthen its mission to "support the Church's mission to evangelize," the Herald released an Advent evangelization issue to **130,000** registered households in the diocese as a tangible effort to invite more Catholics to experience the riches of the Advent liturgical season. The Herald launched an online edition and continued to broaden its digital efforts with Facebook, Twitter, Pinterest, and videos.

# ANNUAL OPERATIONAL FUNDING BISHOP'S LENTEN APPEAL (BLA)

The BLA was started in 1977 as a way to make known the annual diocesan funding priorities to parishioners and to ask for their help in partnering with the Bishop to support and strengthen these ministries and programs. Traditionally, around 50% of diocesan operating income is realized from this annual appeal.





# STRATEGIC LONGTERM FUNDING PARTNERS UNITED IN THE HEART OF CHRIST LEADERSHIP INITIATIVE 2015

In 2015, Bishop Loverde will have served as our Bishop for over 16 years. The desire to "prepare the way" for a new bishop upon his retirement has prompted him to discern and initiate a strategic fundraising effort called Partners United in the Heart of Christ ~ Leadership Initiative 2015.

Launched in 2012, the Initiative seeks to raise \$55.5 million in the short-term to propel future growth of our diocese. To date, \$36.2 million in pledges have been received thanks to the visionary generosity of lay leader parishioner families and the majority of diocesan priests making personal pledges.

## SPREADING THE GOOD NEWS OF THE NEW EVANGELIZATION

\$2.5 million needed to assist parishes in fortifying New Evangelization outreach efforts and to conduct diocesan-wide multimedia initiatives.

To date, more than \$1.4 million has been pledged to help in areas beyond what the BLA has been able to support.



\$1.5 million needed to help expand Respect Life programs and further develop advocacy and media efforts promoting a culture of life and supporting women in need.

- · Funding is helping in areas beyond what the BLA supports with funds for media efforts, program support, and staffing.
- · To date, \$500,000 has been pledged to this area.

# IMPROVING THE FACILITIES OF SAN DAMIANO SPIRITUAL LIFE CENTER

\$1.5 million needed to further renovate and enhance our diocesan spiritual life center.

- This facility annually runs an operational deficit and receives funds from the BLA to offset this.
- Funding will help in areas for capital needs.
- · To date, \$750,000 has been pledged to this area.



## PROVIDING FINANCIAL ASSISTANCE TO HELP CHILDREN ATTEND DIOCESAN CATHOLIC SCHOOLS

\$24 million needed to help grow the diocesan Catholic Tuition Assistance Endowment to \$43 million.

- This Endowment has grown to ~\$27.5 million with new gifts of \$10.5 million and investment returns.
- This fund should provide ~\$1 million in tuition assistance funding for the next school year.
- Since 2010-2011, financial assistance funds have increased from \$2.3 million to \$3.5 million in 2014-2015, providing 1,392



## ADDRESSING THE FACILITY NEEDS OF THE OLDER DIOCESAN HIGH SCHOOLS

\$15 million needed to distribute among the three older high schools (Bishop Ireton, Bishop O'Connell, and Pope Paul VI) for facility improvements.

· To date, \$7.4 million has been pledged to support capital needs of these schools and \$4 million has been divided and distributed as a matching challenge grant to assist them in fundraising efforts.

# STRENGTHENING CATHOLIC CHARITIES PROGRAMS AND OUTREACH

\$6 million needed to fortify Program Endowment and \$2 million to expand critical food assistance, housing, and family counseling programs.

- · Catholic Charities Endowment has grown to \$12 million through new gifts and investment returns.
- This fund should provide \$480,000 in funding for Catholic Charities programs in the coming year.
- · A total of \$2.3 million towards short-term strategic needs has been realized with major support provided to the new St. Lucy Project food distribution program and center.



# FULFILLING THE RETIRED PRIESTS PENSION FUND

\$3 million needed to address the current shortfall in the Diocesan Priest Pension Fund Accrued Benefit Obligation (ABO).

- To date, more than \$1.9 million has been pledged to this area.
- Short-term: Since some priests do not retire for 20-30 years, one way to measure funding is to compare current assets to the value of the benefits earned to date. The Accrued Benefit Obligation or shortfall was \$3 million when this effort started and is now \$1.5 million.





# PARISH FINANCIAL INFORMATION CONT. **SCHOOLS**



Parish schools' operating revenue for 2014 totaled \$89.1 million; tuition and fees accounted for 68% of the total, with the balance made up of tuition assistance, parish investment (subsidy), student services, and local development and

fundraising efforts. Total tuition assistance for 2014 was \$5.6 million. The Diocese Tuition Grant Program funded \$2.9 million and the additional \$2.7 million was funded through the parish, school, or other sources. The parish investment (subsidy), included in income, amounted to 9% of total school income or \$7.6 million. Total operating expenses increased by \$2.4 million or 2.8%.



# ARLINGTON DIOCESAN INVESTMENT AND LOAN CORPORATION (DIAL CORP)

DIAL Corp was established for the benefit of participants and functions to provide savings and loans for the parishes. The investment and loan program administered by DIAL Corp is a collaborative effort where participants deposit excess funds in return for a fixed and stable interest rate, and may request and obtain loans for construction, renovation, or operating needs that also bear a fixed and stable interest rate. The participants of DIAL Corp include the parishes, missions, and schools of the Catholic Diocese of Arlington, along with other related entities such as Catholic Charities of the Diocese of Arlington and the *Arlington* Catholic Herald. The Central Administrative Offices of the Catholic Diocese of Arlington is a separate and distinct entity and is not a participant in DIAL Corp.

As of June 30, 2014, participant deposits earned interest at 2.5% per annum, and participant loans accrued interest at 5.25% per annum. Interest rates are reviewed at least annually and adjusted as necessary. The rate structure has provided for a steady level of net investment income (interest and dividends) for operations.

DIAL Corp has chosen to invest in the Catholic Diocese of Arlington investment pool; approximately \$75 million of investments as of June 30, 2014, are held in the pool. Net assets have increased nearly \$13 million in FY14 due to strong investment performance of the pooled investments. Remaining investments are held in money market, fixed instruments, and U.S. government and sponsored enterprises securities to cover short-term needs of depositors. DIAL Corp has also experienced an increase in deposits, more than adequate to meet the current demands for construction and improvement loans. As of June 30, 2014, \$9 million in loans have been approved which will fund renovation projects in the coming year.
